# SKIP'S STORY

Becoming an alcoholic at age 13 was pretty easy, after all I did have a rough start in life. I didn't have money or fancy clothes, I shopped at the Salvation Army and was always made fun of for being ugly or poor and I was never any good at sports. My father abandoned me, my sister and mother when I was 3 years old. I hated him for that and I always swore that I would never be like him because he was a drunk. I also had major resentment for my stepfather. Life was hard, and it was easy to become an alcoholic.

So my first drinking experience at age 13 was in a bar that my uncle owned in Idaho. My uncle was moving out and we were invited to help. After the move there was beer left in a keg so my uncle started pouring schooners for the grown-ups, then my uncle turned to my mom and said is it OK if Skip has one? My mother told him yes and there it began.

Wow, wow and double wow! I was like a kid in a candy store! I remember taking the beer and drinking it rather fast, then something great happened, all of the previous mentioned issues disappeared and even though I threw up, blacked out and got sick again, I drank more!

And that my dear friends

characterized my drinking until my last drink in July 1975. After countless vain attempts to stop drinking I was allowed to attend a two week outpatient program the Navy offered. The only drawback was I had to attend AA everyday! My life was over because I knew that AA was the place where old drunks went to die.

So like a man facing the gallows, I trudged into my first meeting. I noticed however that people weren't dying, they were laughing and living. All I heard my first meeting was mumble mumble mumble, but I went back the next night and I heard a little more. By the fourth meeting I had taken to AA like a duck takes to water. From that point on I have not found it necessary to take another drink.

I have been through adversities including the death of my spouse of 51 years and thanks to the twelve steps and twelve traditions of AA, I remain sober. When I have drunk dreams. I consider it a spiritual awakening. Standing in front of the beer cooler looking at the different beers, I take it as a further acknowledgement of the fact that I am an alcoholic! (I don't know normal drinkers that do that). I attend two meetings, the one I want to, and the one I don't want to! I don't take sobriety for granted! Cont on pg. 2

I'm an old timer that believes the further I get away from my last drink, the closer I am to my next one! How did I get here? Through great sponsorship.

You see I was never told to find a sponsor, I was told "I am your sponsor!" Thank God for Frenchy who sent me on a path of meetings, book studies, cleaning up after meetings, greeting at the door etc. I did those things because he did those things also when he was in my shoes. So, if I did those things then I had a chance at sobriety!

I cannot express enough the importance of sponsorship, one drunk talking to another! "If you don't give this program away you won't keep it." I've seen it time and time again with people who do not share it and they just disappear.

At meetings when they call for an AA related announcement, I say my name is Skip and I'm alcoholic. This is for the newcomers who stood up and those who didn't, If you are serious about your sobriety and do not have a sponsor, you come see me and we're going to get you hooked up!

Do not think you can do this on your own because trust me, it doesn't work! This is a WE program! I believe there is nothing that accelerates a recovery more than working with others. You owe it to yourself to sponsor and not let the new person slip away.

The first Central Service Meeting was held in the Fall of 1954. Seven A.A. members attended; Jim R., and Ed J., Group II, Matt P. and Leo Q., Sugarhouse Group, Erve H. and Glover G., Murray Group and Johnie W. (Mr. A.A.), Free Lance.

A meeting was organized to raise thirty-five dollars per month to support the A.A. phone that was operated by Mabel M. in her home. Before this meeting the phone was at the A.R.C. (Alcoholism Recovery Center), at the Pony Express Office on Second South St., Downtown Salt Lake City. Since then Central Office has moved to several different locations. Gaining well deserved improvement with each move.

On March 13, 1968 a document showing Articles of Incorporation and Amendment of Central Office of Salt Lake City, were drawn up and signed by Clyde L. Miller, Secretary of State for Utah. These Articles state the purpose of Central Office and the functions it would carry out.

Arlene D. was the first full time employee. Hired in early 1970, she managed the Central Office. Arlene's service continued until she passed away on September 22, 1993. She had over forty-one years of sobriety. Arlene gave much of her time to helping others. Along with the Board of Trustees, part-time employees and volunteers, she kept the office running smoothly for 23 years.

Today there are over 250 meetings listed at Central Office. (1994) Approximately 750 calls received each month and between 900 to 1,000 Newsletters are mailed out in Utah and throughout the U.S.A. Thousands of dollars worth of books and other literature are sold every month to A.A. Groups, Treatment Centers, Alano clubs in Salt Lake City, and other Utah Districts.

### **Treatment and Accessibilities Report**

We are in the process of finding a liaison for our Deaf community in Salt Lake. I have met a wonderful resource at the "Community Deaf Center" named Pamela. She provided many possibilities on how we can get the word out about Alcoholics funding Anonymous (AA), Interpreters, and welcoming Deaf individuals to AA meetings.

I offered to bring a workship to the Deaf Center with the goal of informing people what AA does and does not do. We spoke to a wonderful man named Joseph. Joseph started the first Deaf AA meeting (as far as we know) in the history of AA in Utah in November 2010. Joseph named the meeting "A Moment of Silence." Joseph will have 13 years sobriety on March 3rd. Joseph is now married and has two children.

I asked Joseph if he would help us by creating a video about his experience in AA and how the Deaf can trust the committee to show our love with a warm welcome to AA. If I personally tried to inform the Deaf, I would be dismissed because I am a hearing person. Sometimes our Deaf friends have a trust issue with the the hearing world.

I want to thank all the members and groups that have contributed to the successful opening of the doors of AA to our Deaf friends. With all the generous contributions during the past few years, we all be able to show the best "I love you" AA has ever shown to the Deaf community in Utah.

Our committee is welcoming help from those who wish to volunteer. The best is yet to come.

Over the years the Office has carried the current books and literature from GSO, including the large print editions and different language editions. The Office has flyers on current events and other items of interest. To keep up with modern times and the growth of our A.A. Community, Central Office installed an answering machine for the Deaf on October 4, 1991. Early in the Spring of 1994, a two-line phone system was hooked up to meet the demands of incoming calls. In June 1994, a Computer was donated to the Office and a short time later a printer was added.

The Central Office continues to operate as efficiently as possible with one full time employee/manager. The many volunteers who give their time and service also support the needs of those in recovery and those who want help.

# **CENTRAL OFFICE MEETING MINUTES - FEBRUARY 2024**

#### **BOARD OF TRUSTEES**

**Chair: Wade J.** – Open with Introductions and Central Office Preamble. Commitment is yours the results are mine.

**CO-Chair: Shannon M.** – Excused.

**Secretary: Jennie S.** – New reps: please send me your email, phone number, and home group so I can add you to the contact list. Also, thanks to those who submitted their monthly reports in advance - it really helps to have them for inclusion in the agenda!

**Treasurer: Chris G.** – January was a strong month with high sales and significant contributions, which is typical of the first month in a new quarter. Group contributions were essentially flat relative to 2023 at ~\$5700, and we did not incur any atypical expenses. I've added a simple row at the bottom of the group contribution spreadsheet to indicate year-over-year change if you're interested. Please look at handouts/email attachments for P&L and Group Contributions. Motion to approve P&L passed.

Trustee at Large: Alan B. (District 13 Liaison) – Things are going great in District 13 with solid, diverse, and well attended meetings. Many report attendance by newcomers, old-timers, and everything in between. Attached in your email from Central Office, you will see the latest edition of our District 13 Newsletter, "New Brew", which outlines activities, open positions, and much more. I would like to give a huge thanks to District 13, who just donated over \$1000 to Central Office. We appreciate your generosity more than words can say.

Our District 13 Treatment Chair, Steve, is providing a unique approach called a "Meeting in a Box" to plant seeds and overcome obstacles in regards to getting into some of the treatment centers. We are in need of a couple of District Committee Members (DCMs). Please see me after the meeting or email me: trustee13@saltlakeaa.org if you or some of your AA buddies are interested.

Alternate Trustee At Large: Declan District 10 is going strong. They had forty-ish attendees at their last meeting, with two interested AAs. They're working with Area and District 12 to take responsibility for the upcoming pre-conference assembly, as District 12 is already handling the post-conference assembly. Betsy, the corrections chair, recently gained access to five new pods, and is seeing increasing rates of meeting-attendance fulfillment, including five inmates from this quarter. But recent lock-downs have depressed attendance to the point that no one even showed up at a recent meeting after three lock-downs in a row.

Rick, the alternate Bridging the Gap chair, is gathering volunteers for the program. He has 149 right now, but says the need will soon skyrocket. He could use help from members of other districts. A new treatment center chair, Thomas, was brought in last month, and he's looking to the district for guidance on different programs to launch. He proposed some ideas that members could choose from, and welcomed additional ideas. He's a firm believer in doing a few things to completion, rather than starting multiple ongoing projects.

# SALT LAKE CENTRAL OFFICE Statement of Purpose

The purpose of the Central Office is to provide the basic services listed, to include, but not limited to:

- 1. To carry the A.A. message and help those individuals who suffer from alcoholism.
- 2. To maintain a 24-hour Twelve-Step phone service, and to answer phone inquiries as needed.
- 3. To provide an A.A. listing in appropriate public sources.
- 4. To function as a clearing house for the circulation and exchange of information among all of the A.A. Groups in the area.
- 5. To compile, update and print meeting lists and other information about local A.A. services.
- 6. To maintain A.A. Conference approved literature and Grapevine literature for sale to members and the public.
- 7. To print and distribute a newsletter.
- 8. To be available to those in the community seeking information about alcoholism and A.A.
- 9. To maintain contact, refer inquiries and cooperate with General Service Committees and local groups.
- 10. To arrange, delegate, or manage the details of all Central Office events or any other functions approved by the CO Committee.
- 11. Specifically excluded shall be the operation of any club, clubhouse or drying-out place, and acts in violation of the Twelve Traditions and promotion thereof.
- 12. Provide a limited number of Anniversary coins.
- 13. Such other activities that are consistent with the principles of the Twelve Traditions.

# PAMPHLET OF THE MONTH



Some A.A. members must take prescribed medication for serious medical problems. However, it is generally accepted that the misuse of prescription medication and other drugs can threaten the achievement and maintenance of sobriety. It may be possible to minimize the threat of relapse if the following suggestions are heeded:

- No A.A. member should "play doctor"; all medical advice and treatment should come from a qualified physician.
- Active participation in the A.A. program of recovery is a major safeguard against alcoholic relapse.
- Be completely honest with your doctor and yourself about the way you take your medicine. Let your doctor know if you skip doses or take more medicine than prescribed.

- Explain to your doctor that you no longer drink alcohol and you are trying a new way of life in recovery.
- Let your doctor know at once if you have a desire to take more medicine or if you have side effects that make you feel worse.
- Be sensitive to warnings about changes in your behavior when you start a new medication or when your dose is changed.
- If you feel that your doctor does not understand your problems, consider making an appointment with a physician who has experience in the treatment of alcoholism.
- Give your doctor copies of this pamphlet.

# JOKE OF THE MONTH


### Computers — Male or Female

- 4. As soon as you commit to one, you realize that if you had waited a little longer, you could have gotten a better model.

### Sobriety Died – Denial

Yesterday, I talked to the listener; He who is paid to listen. I explained about my pain. Even took the pills with a tragic sip to cure the pain. But crashing into a wall I found the bottle's bottom. Much too tall - without help, Upward I could not crawl. Deep within - and deep without. I was uncertain what my life was about. Sobriety died - denial lied.

The fire's deep - threaten to surface from stomach to mouth; Just one more drink - I wouldn't. I couldn't do without, Praying aloud - my head bowed. But with each moment the fires burned worse - I needed more alcohol to quench my thirst. This too-muchness was a curse. Only through A.A. Alcoholics Anonymous can such inner stress become reversed, one day at a time.

# STEP 1 - A TWO EDGED SWORD

### You can't stay sober on it

Dr Silkworth had given Bill Wilson his description of Alcoholism. His description included a mental obsession, which could place the single thought of alcohol above and beyond normal thoughts toward family and occupation leading to an unmanageable life. Once the obsession was followed to its conclusion by taking that first drink, the alcoholic experienced the phenomenon of craving, and the physical body became powerless to stop.

From this description, Bill took his first step of recovery when he admitted that alcohol had become his master. He also declared that his life was unmanageable. But Bill failed to enlarge his spiritual life. Soon after taking his first step in recovery, he was released from the hospital. Fear sobered him for a bit. Then came the insidious insanity of that first drink, and on Armistice Day 1934, Bill drank again (Big Book, page 8).

It wasn't until after Ebby had brought him the news of a spiritual solution that Bill was to go beyond the first step. Bill then takes the second and third steps with his childhood friend. He humbly offers himself to God as he understood Him. Then Bill makes the remarkable statement, "I have not had a drink since" (Big Book, page 13). You must get past the first step to develop a defense against that first drink, a defense which must come from a Higher Power.

### You can't stay sober without it

Dr. Bob, an intellect and a deeply spiritual man, believed that the solution to alcoholism had to be a spiritual solution. He was a member of the Oxford Groups of the time and attended many spiritual retreats, prayer meetings and attended church regularly. He was, in comparison, a far more spiritual man than Bill Wilson had been. But alas, his prayers fell short, his spiritual solution failed, and he continued to drink.

Dr. Bob knew the solution was spiritual, he just didn't know that he was powerless. Dr. Bob had a desperate desire to stop, but saw no way out, for he had earnestly tried many avenues of escape. Painfully aware of being somehow abnormal, the man did not fully realize what it meant to be alcoholic (Big Book, page 155). Dr. Bob needed Dr. Silkworth's description of an alcoholic, he needed the first step.

That is exactly what Bill had brought to Dr. Bob. But even after hearing the good news from Bill, he was still not thoroughly convinced. Dr. Bob knew the solution was a spiritual solution, he just didn't believe that he was completely powerless.

After being sober for a number of weeks an opportunity came to travel to Atlantic City to attend a medical conference. Dr Bob got on the train in Akron and was drunk before he reached Atlantic City.

Returning to Akron with the full understanding of his powerlessness, Dr Bob took the first step, and then he followed the plan of action laid out by Ebby, and was never to drink again.

In 1978, after a two year relapse, I got sober for the second time. I was beaten, defeated and humiliated. I was finally desperate enough to take Step One in earnest.

At that point my progress stopped. I really thought I could stay sober on Step One alone. Maybe even learn to do the Two Step; Steps One and Twelve. But I only created more misery, both for myself and those around me.

It wasn't until I took the rest of the Steps that I was able to recover. My lesson came from Bill and Bob's example; I couldn't recover solely on Step One, and I couldn't recover without Step One. It would require Dr. Silkworth's description, Ebby's simple religious idea and the program of action to recover.
